Tier I Priorities

Affordable Housing

- Inclusionary Zoning (Telluride Decision)
- Emergency Housing Assistance Fund

Health Insurance + Affordability

- Colorado/Public Option “New and Improved”
 - Health Care Purchasing Alliance protections
- Drug Price Transparency

Public Health + Human Services

- COVID 19 response issues
 - Support local public health agencies
- Polis Administration Behavioral Health Task Force Recommendations
 - Creation of Behavioral Health Authority (BHA)

Transportation

- Secure new statewide, dedicated revenue sources for transportation
 - Bill(s) to secure fee-based sources for transportation needs

Fiscal Reform

- Defense in wake of Gallagher repeal
 - Ensure Legislature does not take action to change assessment rates
 - Oppose reclassification of residential and commercial

Natural Resources + Environmental

- Agree to form new committee – meet to flesh out purpose and elect chair
- Engage in debate over wildfire mitigation and response funds in Governor’s budget
 - \$6 million request for wildfire mitigation
 - \$4 million for Colorado Water Conservation Board (CWCB) watershed

 - Support Commissioner McNicholas Kury in advocating for local authority and funding.
- Polis Administration Priorities
 - Review & react to DOLA and the Division of Housing legislation.
- Defend Housing Budget Items

Health Insurance + Affordability

- Broad Support for Public Health
 - CALPHO legislation
- Polis Administration Priorities
 - Review & react to HCPF, CDPHE, and CDHS 2021 priorities and budgetary items
- Total Cost of Care
 - CCAT unlikely to support if the bill mirrors 2020 legislation
- Public Health Workforce Concept

- Polis Administration Main Street Initiative

- 2020 Referred Funding Measure
 - Seek to discontinue transportation bonding referred measure.
